Concerns of Village Residents

Speeding on Inverness Road – Colin Rostant: Is aware that the flashing speed sign is to be moved to the north entrance to the village but wants to know what is going to be done to reduce speed on a more permanent basis? Has heard concerns re speeding from many village groups. SBlack confirmed that the sign is being moved. As for other measures, the council is not in favour of speed bumps -can actually cause accidents and can be problematic for snow ploughs. Agreed chicanes are not the answer. CW suggested raising concerns in the consultations for the new Park Plan. There is also the community consultation for Our Community a Way Forward. All households will receive questionnaires -chance to get involved and get concerns highlighted. There will be £2,500 to spend on an action point from this process. Police regularly patrol Grantown to Inverness stretch of road in Carr-Bridge in marked cars. Colin Rostant asked re possibility of using speed camera vans or unmarked cars as well. SBlack agreed to bring it up at next ward council meeting. All agreed it is an ongoing problem, unfortunately with no simple solution. Sign on Inverness Road – Andrew Kirk: Road sign by the Spinney in bad state of repair, Letters flaking off, needs replacing. **SBlack**

Christmas Tree – Linda Jolly: Tree is still at the junction. DR & SB

Our Community a Way Forward: CW, Carol Richie and Roy Brown attended a recent meeting. Discussed progress so far and setting up of the questionnaire.

Minutes of Meeting 27th January 2011 Have been displayed in Post Office. Minutes proposed as correct. Agreed unanimously and signed by SB

Matters Arising

Carr-Bridge Website and Website Hosting CW – Re original website set up, this was done by a working party of both CCC and CTA. The intention being that they would continue to manage it whilst handing it over to the community to run it. Andrew Kirk confirmed the website was registered under the CC. The CTA had ended up running it in as there were no willing volunteers to do so. He had asked the CC to help with costs when they started becoming too much. With regard to the future, it was agreed that Carrbridge.com continue to be owned by the CC and be jointly administered by both the CC and CTA with a 50/50 share of associated site costs. Roy Brown has put in a quote – approx £1400 over 3 years to build new website etc. Still much consultation to go through.

Access Around Carr-Bridge and Leaflet LC – Draft in process.

Signs for No Parking in Ellanwood Road Sign not appeared yet. SBlack

Shed for CC SB – Progressing. Have been negotiating reduction in rent. HC had suggested £100 which the CC thought too much. All agreed to a proposal of £75 per annum. The CC will have to pay for surveyors etc - approx £800 - agreed as is a oneoff expense. Will require planning permission, cost will be half price.

New Play Park Equipment Nothing new to report. SB to speak to Shona Patterson re progress.

Map of Woods DR has original back.

Fly Tipping in the Woods FM – There are two armchairs and some electrical equipment which have been lying by the path in the woods at the south of the village for some time now. SBlack to see if the council will remove it.

Porridge Competition

SB – Would like to see the Porridge Competition go ahead under tangible terms. However, we have to know how we benefit from it, should it continue and if so how? Accounts have been finalised and circulated. Income was £13,523.50 and expenditure £14,967.27. LJ – re the £1443.77 deficit – understood that the £1,400 the CC agreed to give last year was a grant. The event does have to be sustainable but to access funding new angles have to be created. Re breakdown of organising/management fees, roughly works out 93days at £5/6 hour. SB –do we want the event to continue? Agreed yes if sustainable, should at least break even. LJ –Will be difficult, two major funding deadlines have now been missed. Agreed that financial procedures should be put in place. Would like money form both the CC and CTA. SB suggested a porridge meeting for the following Thursday at 7.30 to give LJ time to think her position through. It was also asked that associated websites should be registered under the CC.

The Gathering

Accounts have been finalised and circulated. Income was £13,794.50 and expenditure £4,815.44. A total of £8,979.06 was raised.
